## Please read this privacy policy carefully. Definitions and interpretation

1. In this privacy policy, the following definitions are used:

  - a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - "including" is understood to mean "including without limitation";
  - · reference to any statutory provision includes any modification or amendment of it;
  - the headings and sub-headings do not form part of this privacy policy.

## Scope of this privacy policy

- 3. This privacy policy applies only to the actions of C J Harvey Woodturning and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.

- 40. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
